Ethical, Sustainable and Environmental Policies

At Partridge Events we have long endeavoured to create bespoke, detailed events and visuals with minimum negative impact on the local, global and social environment. Integrating environmental and social responsibility into event planning, we prioritise geographically relevant, conscientious and sustainable suppliers. Where possible we reinvent and redevelop through innovation so as to create one off concepts based on upcycling or reuse.

Onsite Responsibilities & Energy Consumption:

When it comes to creating items and props for our events we use the most sustainable fixings and materials. When onsite and dressing we use low voltage CFL and LED lighting for minimal impact. We are responsible for all waste we generate, taking care to dispose of correctly and always avoiding unnecessary plastics/ non-recyclable waste. We endeavour to cooperate with venues, save on sharable equipment and associated set-up costs so as to maximise efficiency and minimise impact.

Office Responsibilities & Energy Consumption

When it comes to our office working environment, we are always looking at ways to reduce waste. Within our offices we are working towards using less paper. All paperwork is collected by a local recycling centre to be shredded and recycled. We seek to use recycled paper and paper-based materials where possible. We look to be a plastic free environment and recycle all recyclable items. All lighting used is low voltage or energy saving.

Carbon footprint:

We work across the UK (and often overseas) as such, we take responsibility for minimising impact and consumption. We source locally and endeavour to group haulage and travel

where distance is a factor. We consistently tally our movements so as to keep track of impact and cost so as to best benefit both our clients and our global conscience.

Living Décor:

We source all our living décor and props from trusted suppliers as local to each event as possible, the plants are cared for in environmentally sustainable greenhouses displayed at peak condition then returned to home base for further growth. allowing for a floral or green showcase while being long-lasting and sustainable.

Other sustainable options can be faux flowers. They are reusable, look just as good as the real ones and over time regulate their own impact through reuse.

We redistribute single use living décor to local hospitals, care homes, schools or businesses to work towards upholding our goal of zero waste and sit inline with our share and care company ethics.

Social Conscience:

For years we have been working with various charities and organisations passing on materials and items for further use in education and the arts. One of our longest charitable working relationships is with The Children's S.C.R.A.P project is a registered charity No. 281010 which collects, stores and distributes clean, safe, industrial waste to schools, nurseries, colleges, special needs groups, churches, hospital wards, playgroups, community groups and charitable organizations involved in education.

We endeavour to work with local councils and to seek out new relationships to ensure we are passing on any materials of use to any community that may benefit with minimum impact by way of transport cost or wasted opportunity. We have been lucky enough to donate props to Newham Council borough children's hospice.

We work with our staff, freelancers and other contractors to help bring about the growing awareness around sustainability and ensuring reducing environmental impact is at the forefront of our business.
